Personal data that we process

International Students Work processes your personal data because you use our services and/or because you provide these data to us yourself. Below you will find an overview of the personal data we process:

- All information you provide us with via the questionnaire(

 - o First and last name
 - o Gender
 - o Date of birth
 - o Telephone number
 - o E-mail address
- Information about your activities on our website
- Information about your surfing behaviour across different websites (e.g. because this company is part of an advertising network)

Special and/or sensitive personal data that we process

Our website and/or service does not intend to collect information about website visitors under the age of 16. Unless they have permission from parents or guardian. However, we cannot verify whether a visitor is over 16 years of age. We therefore recommend that parents be involved in their children's online activities in order to prevent the collection of information about children without parental consent. For what purpose and on what basis do we process personal data?

International Students Work processes your personal data for the following purposes:

- Matching your profile with vacancies of potential employers
- To be able to call or e-mail you if this is necessary to be able to carry out our services
- Inform you about changes to our services and products
- International Students Work analyses your behaviour on the website in order to improve the website and to tailor the range of products and services to your preferences.
- International Students Work monitors your surfing behaviour on various websites, so that we can tailor our products and services to your needs.

Automated decision making

International Students Work does not yet take decisions on the basis of automated processing on matters that could have (significant) consequences for individuals. In the future, International Students Work may do this. These are decisions that are made by computer programs or systems, without a human being (e.g. an employee of International Students Work) being among them. How long we keep personal data

Sharing of personal data with third parties

International Students Work shares your personal data with various third parties if this is necessary for the execution of the agreement and to comply with any legal obligation. With companies that process your data on our behalf, we enter into a processing agreement to ensure the same level of security and confidentiality of your data. International Students Work remains responsible for these processing operations. In addition, International Students Work provides your personal data to other third parties. We will only do this with your explicit consent. We share your personal data with potential employers to see if your profile matches their wishes. We share data such as your Curriculum Vitae, the data you entered in the questionnaire (<https://forms.gle/Gu2yGLiXtep6G2z6>) and other information we collect through video conversations.
